Naturalization Hearings are usually held once a month at the Federal Courthouse in Pittsburgh at 10:00 a.m. on the third Friday of each month and twice per year in the Erie and Johnstown Divisions of the Court.

The Court maintains an alphabetical index of all petitioners naturalized by this Court until September 30, 1991, and is available to the public during normal business hours. The index contains the name and petition number of all petitioners, and in most cases an address. This information is necessary to complete a form to order copies of Naturalization Petitions and Declarations of Intent available from the National Archives in Philadelphia, where the records are stored. (see address below).

A fee should not be submitted when initially corresponding with the Court. However, any request for Court personnel to search this index must be accompanied by a check made payable to Clerk, U.S. District Court in the amount of \$30.00 to cover the search fee. This form and assistance in completing it are available to the public in the Clerk's Office Intake Section of the Courthouse.
